### **RECOMMENDATION**

Staff recommends the Board receive and file the Monthly Investment Manager Activity, Compliance, and Watch List report for September 2018.

## **PURPOSE**

This item does not specifically support the 2018-19 Strategic Management Plan, but complies with SCERS' investment policy statement reporting requirements and contributes to the effective management and oversight of investment activities.

### **DISCUSSION**

SCERS' investment manager transactions have been reviewed for compliance with their respective investment guidelines and objectives. No compliance violations have been found.

As of September 30, 2018, investment managers on the Watch List include:

1. Carlyle Group (Opportunistic Real Estate).

The following changes were made to the Watch List during the month of September:

• The Carlyle Group was added to the Watch List. The Carlyle Group manages multiple closed-end, opportunistic real estate funds for SCERS, including Carlyle China Realty and Carlyle China Rome Logistics. In September 2018, Carlyle announced it would be exiting the Asia real estate business by the end of 2018. The existing team will be spunout and continue to manage the current investments as a sub-advisor to Carlyle, which will remain the advisor. Following the separation, the existing arrangement of management fees and promote sharing between Carlyle and the new entity is expected to remain in place. Given the change in management structure and increased risk of

further management team departures, the investment with Carlyle has been added to the Watch List.

Och-Ziff Capital Management was removed from the Watch List. Och-Ziff was added to the Watch List in October 2016 following the announcement of legal settlements with the Department of Justice and SEC for violations under the Foreign Corrupt Practices Act. The firm was added to the Watch List for increased business risk, including management changes and additional regulatory scrutiny. Since that time, Och-Ziff has made significant management changes, including the announcement of a new CEO and CIO. Additionally, no new regulatory issues have surfaced and the business has stabilized. SCERS' Staff also recently met with Och-Ziff management in their New York offices. Och-Ziff is removed from the Watch List given the reduced business risk and increased organizational stability.

Staff and the investment consultants will continue to monitor the performance and/or organizational concerns for SCERS' investment managers and update the watch list accordingly.
