RECOMMENDATION

Staff recommends the Board receive and file the Quarterly Trading Activity and Commission Recapture Report for the quarter ending September 30, 2018.

<u>PURPOSE</u>

This agenda item does not specifically support the 2018-19 Strategic Management Plan, but complies with SCERS' investment policy statement reporting requirements and provides a summary of SCERS' investment manager trade execution and Elkins / McSherry Quarterly Trade Cost Summary Report. This item contributes to the effective management and oversight of investment activities.

DISCUSSION

SCERS engages Elkins / McSherry (E/M), a State Street company, to track SCERS' equity and fixed income trading activity and to monitor manager trade execution. E/M analyzes a manager's trade activity against like managers across E/M's universe of approximately 1,400 institutional investors.

E/M's trade analysis report will highlight potential manager trading issues and, if they occur over two or more quarters, Staff will discuss compliance with the manager. The E/M trading cost reports will analyze and compare the following:

- 1. Commission costs, trade costs, and any soft dollar amounts.
- 2. Market Impact Cost, an industry performance metric, which measures the difference between a manager's trade price and the market's volume weighted average price

(VWAP). VWAP is the average security price weighted by the share volume traded that day.


3. Total trading costs.

Industry metrics used to measure trade performance include "cps" (cents per share) and "bps" (basis points = 1/100th of one percent).

SCERS TRADE COST SUMMARY


U.S. EQUITY

- SCERS' U.S. equity managers traded 1.2 million shares across the AMEX, NASDAQ, and NYSE exchanges totaling \$52.6 million in principal, and ranked in the 63rd percentile among the E/M U.S. Equity universe.
- SCERS' total trading costs equaled +2.78 cps, which is 0.45 cps lower than the peer group at +3.23 cps, as follows:
 - Commission cost of +3.35 cps versus +2.01 cps



Market impact cost of -0.56 cps versus +1.22 cps


- SCERS' total trading costs were better than 59% of the peer group.
- A majority of SCERS' U.S. Equity managers experienced unfavorable commission costs compared to the U.S. Equity peer group. Managers with commission costs greater than the average peer group cost of +2.01 cps include:
 - ➢ Weatherbie at +3.57 cps
 - ➢ DGHM at +3.51 cps
 - Eagle Capital at +3.24 cps
- As illustrated below, SCERS' managers generally generate higher commission costs than the peer group.
- SCERS' total trading costs have been consistently below the total trading costs of the E/M universe, with the difference averaging 1.38 cps over the past four quarters.




- The U.S. small cap managers (Weatherbie and DGHM) will typically incur additional commission costs in the form of a soft dollar relationship where, in return for conducting trades through a brokerage firm, the manager receives the brokerage firm's research, generally an additional +2.0 cps.
- According to Elkins / McSherry, the average commission for the Bundled (Research Dollars) commission universe is +3.71 cps, which is higher than all of SCERS' U.S. Small Cap managers in the second quarter.
- The following SCERS' U.S. Equity managers experienced market impact costs that were greater than the peer group cost of +1.22 cps:
 - > Alliance Bernstein at +22.28 cps
 - ➢ Weatherbie at +4.00 cps
- SCERS restructured the U.S. Equity portfolio during the second quarter of 2018, which included terminating the relationship with several domestic equity managers. The number of shares and principal amount traded during the third quarter was significantly below prior quarters.

INTERNATIONAL EQUITY

- SCERS' International Equity managers traded 5.8 million shares totaling \$84.7 million in principal across 25 countries.
- Total trading cost equaled +14.52 bps, which is 8.65 bps lower than the peer group at +23.17 bps, as follows:
 - Commission cost of +6.92 bps versus +13.97 bps
 - Fees (country taxes, tariffs) of +5.95 bps versus +3.81 bps
 - Market impact cost of +1.64 bps versus +5.39 bps



- All of SCERS' International Equity managers analyzed generated commission costs (ranging from +4.28 bps to +9.85 bps), significantly less than the E/M peer group (ranging from +13.88 bps to +14.11 bps). This result is consistent with the previous quarters' lower trade costs versus the peer group, as illustrated below (commission vs. E/M commission).
- All of SCERS' International Equity managers experienced favorable market impact cost versus the peer group during the quarter (full day VWAP vs. E/M market impact), with the exception of Lazard Asset Management at +6.01 bps verus +5.45 bps for the benchmark.
- SCERS' total international trading costs have been consistently below the total trading costs of the E/M universe, with the difference averaging 12.58 bps over the past four quarters.



U.S. FIXED INCOME

- SCERS' U.S. Fixed Income managers conducted 315 trades totaling \$579 million in principal, as follows:
 - Governments: 170 trades totaling \$308 million
 - Mortgages: 98 trades totaling \$246 million
 - Corporates: 46 trades totaling \$23 million
 - > Municipals: 1 trade for less the \$1 million
- Total trading cost equaled +0.04 bps, which is 7.27 bps lower than the E/M peer group, as follows:

- ➢ Governments at -0.10 bps versus +8.17 bps
- Mortgages at +0.15 bps versus +6.08 bps
- Corporates at +0.71 bps versus +8.81 bps
- Municipals at +3.33 bps versus +12.41 bps
- As illustrated below, the total trade cost (in basis points) is consistent with previous quarters' trade costs versus the peer group. SCERS' overall trading volume (in Principal) is consistent with previous quarters, with the exception of first quarter 2018, which was higher due to rebalancing performed across the fixed income portfolio.



- Comparing SCERS' U.S. Fixed Income Core Plus and Treasury managers trade costs versus their peer group is as follows:
 - TCW / MetWest (Core Plus) at +0.03 bps versus +7.25 bps
 - NeubergerBerman (Treasury) at +0.92 bps versus +8.66 bps

INTERNATIONAL FIXED INCOME

- SCERS is invested with Brandywine Global Fixed Income's commingled fund; therefore, trading activity is not tracked.
- Prudential, SCERS' Core Plus Fixed Income manager, is permitted up to a 20% allocation in international bonds or non-U.S. denominated bonds, which is reported as follows:
 - Prudential conducted 102 international trades totaling \$37.7 million in principal as follows:
 - Governments: 70 trades totaling \$27 million
 - Corporates: 27 trades totaling \$9 million
 - Mortgages: 5 trades totaling \$1 million

- Total trading cost was +0.05 bps, which was 5.19 bps lower than the E/M peer group cost of +5.24 bps, as follows:
 - Governments at -0.61 bps versus +5.24 bps
 - Corporates at +5.88 bps versus +5.24 bps
 - Mortgages at -24.86 bps versus +5.24 bps
- > Trading costs were in line with previous quarters' results, as illustrated below.



COMMISSION RECAPTURE

- SCERS' commission recapture program, administered by State Street, instructs investment managers to trade with the program's brokerage partners but only if the trade cost is lower and is the best execution.
- For the third quarter of 2018, SCERS' brokerage partners provided a rebate back to SCERS for approximately 51% of the commissions paid.
 - For the quarter ending September 30, 2018, the commission rebate totaled \$3,688.
 - Year to date through September 30, 2018, the commission rebate totaled \$32,178.
 - For comparison, the commission rebate for the year to date through September 30, 2017 totaled \$33,136.

EXECUTIVE SUMMARY

Elkins/McSherry has been providing trading cost analysis to institutional investors since 1991, serving many of the worlds largest investment managers, pension funds, banks, and broker dealers. Using this vast experience combined with an un-matched collection of global equity market and Universe data, Elkins/McSherry has produced a Trading Cost Analysis on behalf of SACRAMENTO COUNTY. This study evaluates U.S. equity executions from July 1, 2018 to September 30, 2018. The analysis included trading of 1,200,559 shares representing \$52.56 million in principal.

<u>Methodology</u> :

(+) = Cost

The Elkins/McSherry analysis measures trading efficiency by quantifying the cost of brokerage commission and execution quality versus a Full Day VWAP benchmark for each of the securities traded. These data have been aggregated to summarize results by Buy/Sell, Commissions, Market Impact, Short Term Alpha, Market Cap, Trade Difficulty and Trade Detail. These results are quantified in USD as well as being displayed graphically to highlight the outcomes.
