RECOMMENDATION

Receive and file the Quarterly Investment Manager Compliance and Watch List report as of December 2022.

PURPOSE

This item complies with SCERS' investment policy statement reporting requirements and contributes to the effective management and oversight of investment activities.

DISCUSSION

At the August 2022 Board meeting, Staff provided an education on the monthly Investment Manager Activity, Compliance, and Watch list report. The goal of the education was to familiarize the Board with the objectives and layout of the report as well as to survey the Board for feedback on potential changes to the report. As highlighted at the September 2022 Board meeting, and based on the internal Staff discussions and feedback from the Board, the report has been modified to remove the exposure and activity data and convert it into a quarterly report that will only provide reporting related to investment managers on the Watch List and material investment compliance violations from investment guidelines.

SCERS' investment manager transactions have been reviewed for compliance with their respective investment guidelines and objectives. No compliance violations have been found.

As of December 31, 2022, the following managers were placed on the Watch List:

- Sculptor Capital Management Group (Absolute Return)
- Third Point Partners (Global Equity)

Sculptor Capital Management Group was placed on the Watch List due to organizational concerns and underperformance in 2022. SCERS is invested in the Sculptor Domestic Partners II, L.P., a multi-strategy absolute return fund. Third Point Partners was place on the Watch List due to portfolio construction and operational concerns. SCERS is invested in the Third Point Partners, L.P., an event driven hedge fund that resides within SCERS' Global Equity asset class.

Staff removed Mondrian Investment Partners from the Watch List due to the recent termination of the investment mandates managed by the Firm, which included an Emerging Markets mandate and an International Developed Small Cap mandate.

Staff and the investment consultants will continue to monitor the performance and/or organizational concerns for SCERS' investment managers and update the Watch List accordingly.

1 1	Sculptor Capital Management Group	Absolute Return	\$ 58,095,695	Performance and Organization	Jan-23	Sculptor Domestic Partners II, L.P. is a diversified multi-strategy fund within SCERS' Diversifying asset category that invests on a global basis across North America, Europe, and Asia in fundamental equities, corporate credit, structure credit, and merger arbitrage strategies. The firm is exploring potential options to restructure ownership of the company and Staff and Consultant are concerned with the potential risks of increased turnover among senior professionals and future losses in AUM. The Fund has also underperformed other absolute return fund peers and multi-strategy indices during 2022. Year to date through December, the Fund has declined -11.6% versus the HFRI Fund Weighted Composite Index down -4.3%. Given the performance and organizational issues, Sculptor was placed on the Watch List, and Staff will monitor Sculptor's performance and organizational changes.
2	Third Point Partners	Global Equity	1 1 62 062 228	Portfolio Construction and Operational Concerns	Jan-23	Third Point Partners, L.P. is an absolute return fund that resides within SCERS' Global Equity portfolio and was placed on the Watch List due to an increase in private equity exposure and operational concerns. The Fund employs an event-driven, opportunistic investment strategy to invest globally across asset classes including, public equity, credit, and private equity securities. Although the fund invests across asset classes, it is predominately invested in public equity. However, with the public equity portfolio facing significant decline in 2022, the private equity exposure has increased as a percentage of the overall portfolio from 4% in June 2021 to over 9% as of October 2022. The increase in private equity exposure creates a potential liquidity mismatch risk to investors. Staff will closely monitor Third Point going forward.
