

# NOTICE OF ELECTION

Notice is hereby given that Sacramento County Employees' Retirement System will conduct a Member Election during the period of September 19 through September 30, 2016 for the purpose of electing to the Board of Retirement:

## ONE MISCELLANEOUS REPRESENTATIVE

The term of office begins January 1, 2017 and ends December 31, 2019.

**ELIGIBILITY:** In order to be a candidate or to be eligible to vote in the election, an employee must be an active miscellaneous member of the Sacramento County Employees' Retirement System according to System records. Only miscellaneous members may be candidates and/or vote for a Miscellaneous Retirement Board Representative.

### CALENDAR OF EVENTS

August 8, 2016, 8 a.m.	First day to obtain candidate's nomination papers
August 19, 2016, 5 p.m.	Last day to file candidate's nomination papers along with a candidate's statement not exceeding 200 words; Filing must be done in person; Electronic filing not accepted
September 19 to September 30, 2016	Voting period (by mail ballot); if using hand delivery or inter-office mail (mail code 133-01A), ballot must be delivered to the Elections Office by 5:00 p.m. on September 30, 2016; or if returning by U.S. mail service, ballot must be postmarked by September 30, 2016 and received by the Elections Office by 5:00 p.m. October 3, 2016.
September 30, 2016, 5 p.m.	Last day to cast ballot/End of Voting Period
October 6, 2016	Official results released
January 1, 2017	Term of office begins

**CANDIDACY INFORMATION:** Nomination papers and candidate's statement forms may be obtained and filed at Voter Registration and Elections, 7000 65<sup>th</sup> Street, Suite A, Sacramento, CA 95823, Monday through Friday, from 8 a.m. to 5 p.m. Candidates are requested to pick up and file their nomination papers in person. If a representative is delegated this responsibility, a specific letter of authorization signed by the candidate will be required.

Each candidate is allowed one 200-word statement of qualifications, which will be included in each member's voting material. This statement of qualifications is not verified or corrected by Voter Registration and Elections staff. It will be printed exactly as presented.
